

Treatment agreement Craniosacral / Massage Therapy

This is a treatment agreement from Susanna Redeker within the framework of the Medical Treatment Act (WGBO, 1995) for the application of craniosacral therapy / massage therapy. This law strengthens the position of doctors, paramedics and other care providers. The WGBO Act regulates, among other things: right to information, consent requirement for treatment, obligation to create a client file, right of access to the file, confidentiality of client data. This treatment agreement / intake serves for transparency between therapist Susanna Redeker and the client.

Susanna Redeker, therapist affiliated with the Association for the Promotion of Alternative Medicine (VBAG), is bound by the guidelines stated in the VBAG Professional Domain and Competency Profile and the Ethics and Code of Conduct Regulations. It falls under the disciplinary / complaint law of the VBAG.

It is intended that the client completes, signs and gives this form to the therapist and keeps a copy for himself. The other form is kept in the client's file.

The client is aware that the therapist, Susanna Redeker, can obtain information from the GP or treating specialist if desired by the therapist. The therapist first informs the client of this.

The costs * is per treatment for adults:

- An extension of 10 minutes is possible, after that (in consultation) it costs € 7.50 per 15 minutes. The costs * is per treatment for children:
- From approximately one hour to € 60.00
